
<u>Class Assignments: In-Person and Scholars@Home Online Independent Study</u> <u>Program</u>

Your child's class assignment for the 23/24 school year will be available starting at **10:00 AM on Monday**, **August 7th** through your <u>Aeries Parent Portal</u>. Please remember that there will **NOT** be any class lists posted at school sites.

Please note, your child's class list will only be visible in the <u>Aeries Parent Portal</u> if you have <u>completed the Data Confirmation</u>. The Data Confirmation is your review of the beginning of the year documents, for example: *emergency card, photo authorization, student technology use agreement*, that require parent/guardian signatures. Data Confirmation is available now to complete in Aeries Parent Portal.

School Bus Transportation Applications for the 2023-2024 School Year

The Sulphur Springs Union School District is able to provide bus transportation to and from school for a limited number of students. Transportation applications are being accepted **NOW** for the 2023-2024 school year. The Transportation Department will do their best to accommodate students riding the bus that wish to ride. However, please know that turning in your application does not guarantee your child a seat on a bus. Students who are not placed on routes will be placed on a waitlist. Students will be added to bus routes based on eligibility and space.

In order for students to ride the school bus at the start of the school year, bus applications MUST be submitted in advance. Applications are available online, located on the District website. If a parent needs a printed application, please go to the school office and/or the District Office located at 27000 Weyerhaeuser Way. It is important to remember that any child that is riding a school bus, must have an application on file *prior to boarding*.

Important: Until you have received a confirmation from the Transportation Department that your child's application is accepted and approved, your child will not be able to ride the bus.

The District's Transportation Safety Plan can be found on the District's website. Buses will have active video monitoring enabled. The use of video monitoring will support the safety of students and drivers and prevent vandalism, and may be used to monitor student behavior.

Identity document (one of the following):

- · US Driver's License
- · Government ID: State ID, U.S. Military
- · Passport (current from any country)
- · Individual Taxpayer ID Number
- · Matricula or Visa Consular Card
- · Birth Certificate (any country) for the minor that is the Benefit Qualifying Person



Eligibility document (one of the following):

- · Monthly statement from Medi-Cal, CalFresh, WIC, SSI
- · Proof of participation in Free or Reduced School Lunch program, CEP designated school
- · Pell Grant Award Letter
- · Proof of participation in a qualifying support program for Indigenous communities
