Dr. Joshua Randall, Deputy Superintendent of Business Services, welcomed Mr. Khushroo Gheyara, Executive Vice President of Caldwell Flores Winters, Inc. Mr. Gheyara shared with the Board of Trustees, that documentation for, the purpose of permitting the District to issue on behalf of its Community Facilities District No. 2019-1 (the "CFD"), a series of Special Tax Bonds (the "Bonds"). Mr. Gheyara shared that the proceeds of the Bonds will be used for purposes including acquisition, improvement, and equipping of certain School District Facilities, funding a reserve account for the Bonds, paying for capitalized interest on the Bonds, if necessary, and paying costs associated with the issuance and delivery of the Bonds.

The Resolution approves the form of four additional documents: a Fiscal Agent Agreement between the District and U.S. Bank Trust Company, National Association, as Fiscal Agent, which establishes the terms of the Bonds; a Bond Purchase Agreement between the School District, on behalf of the CFD, under which the Underwriter will agree to purchase all the Bonds, and a Preliminary Official Statement, with attached Continuing Disclosure Agreement, the disclosure document under which the Underwriter will market the Bonds.

The Board of Trustees thanked Mr. Gheyara for his time and preparation.
