Dr. Fullwood invited the Board of Trustees to attend any or all of the 2019 Winter Band and Chorus Events.

Mrs. Martinez Gerson was evacuated during the Tick Canyon Fire. She thanked Dr. Kawaguchi, the District team, teachers, families and children for their patience as we dealt with the school closures. She was sad to hear some families lost their homes. She commended the District's commitment to our families.

Mrs. MacDonald thought it was great how the District reacted with good communication. She thought that it was nice to have non-emergency procedures to practice before hand. She stated that we can look back and see how we can improve our systems for school closures. She was also grateful for the Social Services support for our families.

Mr. Chase thanked everyone and Dr. Kawaguchi for literally putting out some fires. He also thanked Mr. DeFigueiredo for reaching out to the Board of Trustees and keeping them informed while saving Dr. Kawaguchi time to handle other important details. He thanked Dr. Kawaguchi for being proactive before we even knew there was damage and looking into our children's safety. He thought it was fiscally sound to take care of damages now. He expressed his sentiments to the families who lost their homes. Mr. Chase noted that Pinetree Community School was having a fundraiser on November 13, 2019 to support the families who lost their homes in our area. He also expressed the good idea of the District hiring a security company. The company brought to the District's attention that local neighbors were parking their cars and blocking the entrance of Mint Canyon Community School at night. The security company worked with the neighbors to move their cars, and by them doing this, assisted the fire fighters to get to the school to save it.

Mrs. Weinstein thanked Dr. Kawaguchi for keeping the Board members informed. This was very helpful when running into people in the community who wanted information. She noted attending the CLASS Foundation Kick-off and thought it went really well. The Foundation also received some donations that night. She thanked everyone who participated. Mrs. Weinstein concluded by announcing how proud she is to be a new grandmother.

Mr. DeFigueiredo congratulated Mrs. Weinstein and Ms. Carrillo for their new grandbabies. He also attended the CLASS Foundation Kick-off and was able to speak to quite a few people who were very enthusiastic about the whole idea, and how the Foundation will support all students. Mr. DeFigueiredo

noted attending the Wellness Collaborative meeting. He encouraged the other Board members to attend a future meeting. He mentioned the wonderful presentations and how nice to see a room full of people wanting to provide care for our children and see them succeed. He concluded by thanking Dr. Kawaguchi for her great communication during the Tick Canyon Fires, the Board of Trustees for their patience with the communication structure, the First Responders from in and out of state who helped protect our schools, the wonderful Maintenance & Operations staff who worked very hard, and he expressed his sincere condolences to the families who lost their homes.

Dr. Kawaguchi thanked Dr. Randall for his extraordinary leadership during the Tick Canyon Fire and school closures.
