Dr. Kawaguchi presented to the Board of Trustees Resolution No. R-23-47. The Governing Board of Trustees adopted Resolution No. R-23-02 authorizing the District to approve change orders associated with certain design changes and accommodate several unforeseen conditions that were discovered during the demolition of portions of the existing school office. Change Order 7 is associated with change orders 5 and 6, that were presented at the January 18, 2023, and February 8, 2023, Board meetings, respectively. Change Order No. 7 includes several minor miscellaneous items that were in the review process at the time change orders 5 and 6 were presented to the Board or were not known at the time the change orders were being considered by the Board. The final change order also includes the final general contractor's general conditions associated with the additional time required to complete the project caused by the changes. The cumulative value of all change orders is \$1,053,297.49, including Change Order No. 7. Resolution R-23-47 authorizes the additional unforeseen site improvements associated with the new primary grade classrooms by making the required statutory findings. Dr. Greenlinger stated that the Memorandum of Understanding between Sulphur Springs Union School District and CSEA Chapter #298: Catastrophic Leave is a continuation of an existing Memorandum of Understanding with CSEA Chapter #298 that provides employees with a bank of donated sick time from other employees, to be used in extreme circumstances. This renewal contains a few minor adjustments, which were written in response to the District and CSEA's experience utilizing this leave for the first time. The changes include an increase in the number of days that can be requested to better align catastrophic leave with similar statutory leaves. Additionally, this renewal allows retiring employees to donate their accrued sick time. Lastly, this renewal includes a provision that maintains a bank of unused donated sick time, which will quicken an employee's access to this leave.
