Dear Parents, Guardians, and Community Members,

We would like to thank you once again for your support in passing Measure CK in June 2012. Measure CK is supporting Sulphur Springs Union School District in continuing its tradition of providing a high quality education to Canyon Country's elementary school students. Funds from Measure CK have been used to upgrade technology in classrooms district-wide, update playgrounds at Leona Cox, Pinetree, and Sulphur Springs Community Schools, and retire debt to allow additional resources to be used for classroom instruction. In addition, Measure CK funds have also supported the modernization and new construction at Valley View Community School, which includes a facility for severely disabled and medically fragile students. Presently, the District is preparing for the new construction of a 12-classroom wing and modernization project at Pinetree Community School.

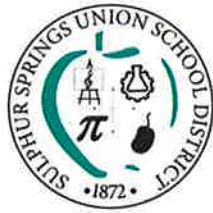
A Citizens' Bond Oversight Committee is a requirement to satisfy the accountability requirements of Prop 39, which allows passage of a bond measure by 55 percent of voters. Committee members' duties include informing the public about the District's expenditure of bond proceeds, reviewing expenditures to ensure funds are spent only for purposes identified in Measure CK. The committee meets no more than 4 times per year and is comprised of seven members who represent various community members including:

- One (1) member who is the parent or guardian of a child enrolled in the District.
- One (1) member who is a parent or guardian of a child enrolled in the District and active in a parent-teacher organization, such as the P.T.A. or School Site Council.
- One (1) A member who is active in a business organization representing the business community located in the District. An example would be someone who is a member of the local Chamber of Commerce, Rotary, etc.
- One (1) A member who is active in a senior citizen's group. An example would be someone who is involved with a local senior citizen's group, an AARP member, etc.
- One (1) A member who is in a bona-fide taxpayer's association. An example would be someone associated with an organization that has taxation as one of its interest, such as the League of Women Voters, Howard Jarvis Group, CPA, etc.
- Two (2) members who are part of the community at-large.
